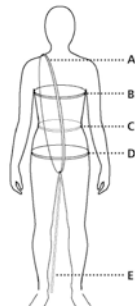
- Photos will not be returned. We cannot store more than 8 photos per submission; extra photos are shredded upon receipt for your privacy.

**How to take correct measurements:**

A leotard must be worn when taking measurements, *not street clothes*. Have measurements taken by the student's dance teacher if possible, making sure they leave no room for growth.



**A. Girth:** Measure from shoulder through crotch and back to start.

**B. Chest:** Measure the fullest part of the bust, keeping tape measure parallel to the floor. This is NOT your bra size.

**C. Waist:** Measure around narrowest part of the upper body.

**D. Hips:** Measure around fullest part of the lower body.

**E. Inseam:** Measure inside of leg, from crotch to two inches below ankle bone.
